* Graduate Student Readers and Tutors who are appointed for less than 110 hours, but who subsequently complete 110 hours or more of actual work during the academic quarter, will be reimbursed for the mandated GSHIP fee and the Educational & Registration fee remissions, unless paid by other university sources. When the minimum requirement of 110 hours of actual work has been met, the Department will forward a reimbursement request and copies of approved timesheets for the quarter to the Graduate Division office (120 Aldrich Hall, Attn: Tina Choi, Zot: 3180) for processing. (See also UCI AP-61).

- For AY 2008-2009, the Academic Student Employee (ASE) fee remission amount is equal to 100% of the Educational fee, 100% of the Registration fee, and 100% of the GSHIP (health insurance) fee.
- Total Assessment for Residents include the Local Fees, which is not covered by the Fee Remission. Total Fees are assessed to all full-time students by the Registrar's each quarter. - Local Fees include the Associated Graduate Student Fee, Student Center Fee, Bren Events Center Fee & Recreation Center (ARC) Fee.
- Total Registration and Educational Fee Remission includes the additional Educational Fee Differential of \$104.00 per quarter for non-resident graduate students only.
- Total Assessment for Non-Residents include the Local Fees and Non-Resident Tuition, which is NOT covered by the Fee Remission. Total Fees are assessed to full-time students by the Registrar's each quarter. For a breakdown of student fees, please refer to the Registrar's website.
- Eligible Non-Resident Ph.D. students that have Advanced to Candidacy are exempt from paying the Non-Resident Tuition for a maximum of three calendar years.
- Schedule does not apply to students in the self-supporting EMBA/FEMBA/HCEMBA programs.
- Local Fees for PSMOB students are slightly higher than the Local Fees for regular graduate students.
